- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: KLJ identified one wetland basin within the study area that meets the criteria established in the 1987 Corps Wetland Delineation Manual and Regional Supplement. As previously determined (April 2001), the basin is an isolated, intrastate and non-navigable water not utilized for recreational or industrial purposes. This wetland does have an outlet; however, it drains to the south and west to another isolated basin. The closest jurisdictional tributary to the Heart River (TNW) is approximately ½ mile to the east. There is no hydrological connection between these basins and any of the closest tributaries to the Heart.
