- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: [The JD review area contains two unnamed wetlands; a 0.6 acre wetland and a 4 acre wetland. The unnamed wetlands are located within entirely closed drainage basins with no discernable surface outlets. The 4 acre wetland does have an upland swale outlet that appears to carry flows in only the wettest of years, if at all. The wetlands are not located within a reasonably close proximity to jurisdictional other waters; whereby, nonspeculative ecological connection\(s\) could be made. Further, these wetlands: 1\) are not used by interstate or foreign travelers for recreational or other purposes; 2\) do not support fish or shellfish that could be taken and sold in interstate or foreign commerce; and 3\) are not used for industrial purposes by industries in interstate commerce.](#)
