**B. ADDITIONAL COMMENTS TO SUPPORT JD:** [The isolated playa is a natural depression completely surrounded by upland with no evidence of any "continuous surface connection" or flow to other potentially jurisdictional waters. The playa lakes within this region are generally formed by collecting precipitation which is held at the surface by a natural clay layer preventing infiltration. They are not created by exposure of groundwater. The fact the playa is naturally small in size with limited public access indicates there is no potential for the area to \(1\) be used by interstate or foreign travelers for recreational purposes, \(2\) produce fish or shellfish which are or could be taken and sold in interstate or foreign commerce, or \(3\) be used for industrial purposes by industries in interstate commerce.](#)
