determination. Approximately 49 acres of property is included in this jurisdictional determination. Located on the parcel are four (4) isolated, intrastate, non-navigable wetland basins with one basin extending beyond the parcel to the east. Wetlands are 7.29 acres (approximately 4.48 acres located on this parcel), 0.19 acre, 1.01 acres and 3.66 acres for a total of 9.7 acres. No tie to interstate commerce can be made other than through migratory birds. The basins are not jurisdictional based on the SWANCC ruling.
