determination. Approximately 10 acres of property is included in this jurisdictional determination. One isolated, intrastate wetland basin approximately 3.2 acres in size was identified. No tie to interstate commerce can be made other than through migratory birds. The basins are not jurisdictional based on the SWANCC ruling.
