ADDITIONAL INFORMATION SUPPORTING NJD (e.g., paragraph 1 – site conditions; paragraphs 2-3 – rationale used to determine NJD, including information reviewed to assess potential navigation or interstate commerce connections; and paragraph 4 – site information on waters of the U.S. occurring onsite): The proposed project involves development of a 30 acre site with three farmed wetlands on it. The project has impacted a small wetland of approx. 0.7 acres in size and has previously been determined to be isolated/nonjurisdictional. This phase of the project will impact a 1.7 acre wetland that is considered isolated/nonjurisdictional. The entire area is, and has been cropped. The USGS Quad map, USNRCS and NWI wetland maps, local knowledge and an on-site visit were utilized to make the determination. The waterway has no viable surface hydraulic connection to WoUS, is not navigable, and has no viable ICC. A third wetland on the site is not to be disturbed by this project.
