The Farmers Highline Canal flows to Big Dry Creek that flows to the South Platte River, which is an interstate waters. The wetlands of Ryan Gulch flows to the Farmers Highline Canal. The Seep Wetland flows to the Croak Canal that flows to Big Dry Creek. The wetlands of Broad Lake are supported in part by the leaking of the Farmers Highline Canal. These wetlands are adjacent to the Farmers Highline Canal.
